General Billing Information

Item	Description
Billing Cycle	Bills mailed on or about the 20th of each month
Due Date	10th of each month
Delinquent Status	Accounts unpaid after the due date
Cutoff Date	Monday following the due date
Office Hours	Monday–Thursday, 8:00 a.m.–4:30 p.m.


Tariff Reference: Bills become delinquent if not paid by the due date. Final notice is issued prior to disconnection.


Water Rates (5/8" x 3/4" Standard Meter)

Usage	Charge
0–1,000 gallons	\$42.50 minimum
Each additional 1,000 gallons	\$7.50 per 1,000 gallons

Tariff Reference: A monthly minimum rate applies whether or not water is used during the billing period.

6" Compound	50.0	\$42.50
6" Turbine	62.5	\$42.50
8" Compound	80.0	\$42.50

Tariff Reference: Larger meters are billed using the standard base rate multiplied by the AWWA meter equivalent.



Delinquency, Disconnection & Administrative Fees

Fee Type	Amount
Late Payment Fee	\$25.00
Administrative Delinquent Fee	\$20.00
Disconnect Fee	\$75.00
Reconnect Fee	\$75.00

Tariff Reference: Service may be disconnected if delinquent bills are not paid by the cutoff date or for other Tariff violations.



Service & Field Fees

Service	Fee
Service Trip / Meter Re-read	\$75.00
Meter Test (upon written request)	\$75.00
Extended Service Trip (over 1 hour)	\$75.00 per employee per additional hour

Tariff Reference: Fees apply to customer-requested trips, inspections, investigations, or collection-related visits.

Meter Tampering, Locks & Property Damage

Violation	Fee / Penalty
Cut Lock – First Offense	\$150.00
Cut Lock – Second Offense	\$250.00 + meter removal
Cross-Connection	Service disconnected to all parties
Equipment Damage / Property Damage	Actual repair, replacement & lost water costs
Meter Tampering Penalty	Up to 6× Base Rate (in addition to damages)

Tariff Reference: Tampering penalties apply only to the individual responsible and are assessed in addition to repair costs.

Payment-Related Fees

Fee Type	Amount
Returned Check / Non-Negotiable Payment	\$30.00

Tariff Reference: Applies to checks, drafts, or similar instruments returned by a financial institution.

Service Investigation Fees

Service Type	Fee
Standard Service Investigation	No charge
Nonstandard Service Investigation	Cost-based (admin, legal, engineering)

Tariff Reference: Nonstandard service requests require a formal investigation and contract prior to service approval.
